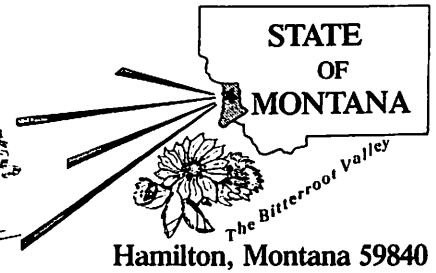
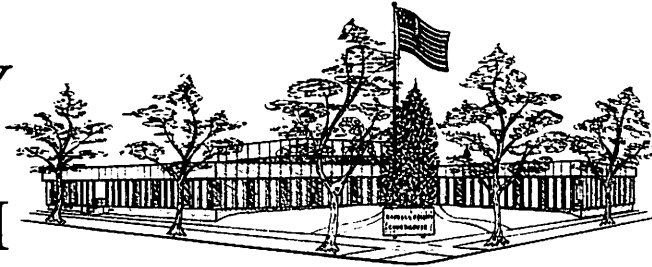

This letter is to confirm that the Ravalli County, in accepting the FFY 2020-21 EMPG grant is fully aware that project funding will be conducted as follows:

It is understood the total project cost projection is based upon Federal funding estimates and may be still be subject to change. It is also understood that Ravalli is prepared to satisfy their joint match by either cash or well-documented, fully eligible "in kind" contributions. The value of these local contributions may exceed the minimum (50%) match amount requirement but may not be less than 50% of total costs at any time during the grant performance period. We understand that we may be reimbursed only up to 50% of total costs incurred.



7.
