PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Montana Department of Environmental Quality’s (DEQ) intention to issue a General Permit as described in this notice. This permit is issued by the DEQ under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); and Sections 402 and 303 of the Federal Clean Water Act. The Water Protection Bureau has prepared a draft permit for the facility listed below. APPLICANT INFORMATION

- PERMIT/CATEGORY: General Permit; Produced Water
- GEOGRAPHIC REGION: Statewide
- FACILITIES: Oil and Natural Gas Production Facilities
- RECEIVING WATERS: Statewide Ephemeral Water Bodies
- PERMIT NUMBER: MTG310000

The renewal of this Produced Water General Permit (PWGP) will continue to provide statewide general permit coverage for owners/operators of oil and gas production facilities that discharge produced water into statewide ephemeral drainages and impoundments constructed in ephemeral drainages. The renewal is for a five-year cycle.

This PWGP only permits the discharge of produced water for beneficial use, specifically for wildlife and livestock watering. The permit includes effluent limits and has two prerequisites: a receiving water storage capacity self-evaluation to ensure discharge is contained in ephemeral drainages, and a water quality analysis to ensure the produced water is of high enough quality for wildlife and livestock watering. Indian Lands, National Parks, and the state waters in Rosebud Creek, Tongue, Powder, and Little Powder River watersheds are excluded from General Permit coverage.

## PUBLIC COMMENT

Public comments are invited ANYTIME PRIOR TO CLOSE OF BUSINESS December 7, 2020. Comments may be directed to the DEQ Water Protection Bureau, P.O. Box 200901, Helena, MT 59620. All comments received or postmarked PRIOR TO CLOSE OF BUSINESS December 7, 2020 will be considered in the formulation of final determinations to be imposed on the permits.
