The **Hamilton City Council** will hold a public hearing on **Tuesday, January 5, 2021** and on **Tuesday, January 19, 2021** to take public comment on **Zoning Request #2020-08**. The request made by Michelle Stainbrook of M Squared Investments, LLC to rezone an 11,160 square foot (0.26 acre) parcel from Single-Family Residential (RS) to Residential High-Density (RH).
