## **Hello Stevensville Friends and Neighbors,**

The Montana Department of Transportation (MDT) is continuing to prepare for the **North of Stevensville-North project**. This project will make Secondary 203 (Eastside Highway) a safer and more efficient travel experience by reconstructing nearly 6 miles of the highway, just south of Florence. It will provide:

- 12-foot-wide travel lanes
- 12-foot-wide center two-way left-turn lane
- 4-foot-wide shoulders
- Safer roadside slopes and ditches
- Improved road surfacing and drainage
- A large radius horizontal curve at Rathbun Lane
- A 4-legged roundabout at Ambrose Creek Road

MDT has been working on the project's design, listening to public feedback, and invite you to chat regarding the construction schedule, project progress, and design updates.
