A quick reminder for next week: The Montana Department of Transportation (MDT), in partnership with Robert Peccia and Associates (RPA), invite you to attend an open house on Tuesday, October 18, 2022. Two events will be held on this day to ensure all interested parties can attend. The same information will be provided at both open house sessions. The study team will provide an update on the current status of the study and will be available to answer questions.

The in-person event will be held from 4:30 – 6:30 p.m. at Lolo School (11395 Highway 93 South) in the lower gym. No formal presentation will be made at the in-person event.

MDT and RPA are collaborating to complete a study between Lolo and Florence on US Hwy 93 south of Missoula. This study will investigate the best possible future improvements to support growth within the area, increase safety and provide an improved travel experience for drivers.

The roadway study will be conducted in the late summer and fall of 2022 and into 2023, with results expected towards the end of 2023 or early 2024.
