The Montana Department of Commerce has completed revisions to the 2021 Consolidated Annual Performance and Evaluation Report for the period of April 1, 2021 to March 31, 2022. These revisions include the addition of the Community Development Block Grant (CDBG) State Performance Evaluation Reports.
