WATER WAS HISTORICALLY DIVERTED FROM CANYON CREEK AT A RATE OF 336.6 GPM USING A HEADGATE LOCATED IN THE NENENE OF SECTION 29, T6N, R21W, RAVALLI COUNTY. WATER WAS DIVERTED FOR IRRIGATION OF 71.9 ACRES CONSISTING OF 23.5 ACRES IN THE NWNE, 25.4 ACRES IN THE NENW AND 23 ACRES IN THE SENW, ALL IN SECTION 35, T6N, R21W, WITH A HISTORICALLY DIVERTED VOLUME OF 54.2 AF AND A HISTORICALLY CONSUMED VOLUME OF 5.9 AF.
