US 93 light replacement

DARBY, Mont. - The Montana Department of Transportation (MDT), along with construction partner Neely Electric, will be replacing luminaires, or light fixtures, on US Highway 93 (US 93). The project area begins in Darby and continues north to Stevensville. The work is scheduled to begin June 19, weather permitting.

The luminaire replacement work is expected to last for approximately four weeks. Work will take place overnight between the hours of 7 p.m. and 6 a.m. Night work minimizes traveler impact.

Travelers can expect reduced speeds and single lane traffic in both directions through the project area while work occurs.

MDT encourages the public to be cautious at all times and leave additional time for travel. MDT wants everyone to remember the three S's of work zone safety: speed, space and stress. Slowdown in work zones and follow speed limits. Leave enough room around your vehicle. Stay calm and pay attention to the road. If you're driving and want to check in, pull safely off the road and dial 511. Tune in to local radio stations and watch for variable message signs along the route.
