

While I appreciate the effort that has gone into preparing the 2023 Community Wildfire Protection Plan, the plan misses some extremely important perspective that must be taken into consideration going forward:

1. The plan does not call out *anthropogenic* climate change as a major cause of the increased fire danger that we see. We are dealing with far more than simply years of fire suppression and unfettered home construction in the wildland urban interface.
2. Cutting the forest and converting it to a plantation landscape does not significantly reduce the threat of severe wildfires in the climate era, which is characterized by extreme and sometimes sudden drought, flood and wind events. A study in Canada found that forest thinning is effective under historic conditions but under the dry, hot, windy conditions of the climate change era thinning is *not* effective in reducing fire severity.
3. The most effective protection of homes and property in the Wildland Urban Interface is aggressive treatment of the home ignition zone around homes. This should be given number one priority in the CWPP and should be the main emphasis and position of the County.
4. Thinning of the forest up to the wilderness line is a waste of valuable resources, compacts soils and ruins our beautiful mountain vistas from the valley with many miles of logging roads. It would be more cost-effective to subsidize conversion to metal roofs for everyone living in the WUI.
5. A tree requires 20-30 years to turn from a carbon source to a carbon sink. We therefore need every mature tree to be left standing that we can possibly allow. Only this will mitigate the real danger that we face in the long run. Planting new trees does not forestall the consequences of the additional carbon they will introduce over the next 20 years, nor the loss of mature trees to logging. We do not have this time to waste.
