Our road department employees are experienced in the use of this equipment and are perfectly capable of providing taxpayers with a professional quality driving surface.

Our properties are devalued by deteriorated roads and inferior asphalt patching practices currently being performed.

We will be content when employees perform road repairs properly the first time.
