PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Department's intention to issue wastewater discharge permits to the facilities listed in this notice. These permits are issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA) and the Administrative Rules of Montana 17.30.1001 *et seq.*, Montana Ground Water Pollution Control System (MGWPCS). The Water Protection Bureau has prepared draft permits for the facilities listed below. Copies of the draft permits, statements of basis, and environmental assessments are available upon request from the Water Protection Bureau or on the Department's website www.deq.mt.gov

A tentative determination has been made by DEQ to modify the existing Montana Ground Water Pollution Control System (MGWPCS) permit, MTX000099, for the Roseburg Forest Products Co., Missoula Facility. This permitting action modifies and reauthorizes discharge of industrial wastewater to the shallow receiving ground water underlying the existing discharge structure (Outfall 001).

Outfall 001 (infiltration pond) is located in the Southeast ¼ of Section 8, Township 13 North, Range 19 West; or 46° 53' 48.7" North Latitude and -114° 01' 28.2" West Longitude.

This is a renewal of the Montana Ground Water Pollution Control System (MGWPCS) permit issued to Jefferson Local Development Corporation (permittee) for Sunlight Business Park (facility). The facility is located west of Golden Sunlight Mine Road north of Interstate 90 in Whitehall, MT. The domestic raw wastes entering the facility are expected to be residential strength in nature. The facility proposes to discharge treated wastewater into Class III ground water via one outfall (Outfall 001)

Each lot has an individual dual compartment septic tank with an effluent filter that removes most of the floatable and settleable solids from each individual lot's raw waste stream. The effluent from each individual septic tank is then pumped via a low pressure sewer main into a dose tank. From the dose tank, the effluent is pumped through a small diameter sewer force main into a 10,000 gallon capacity recirculation tank. The effluent is then pumped from the recirculation tank into one of six AdvanTex™ AX100 pods (Level 2 treatment). The effluent from the AdvanTex™ system is either returned to the recirculation tank for additional treatment or directed into the 4,000-gallon dose tank for subsequent disposal at a 4:1 ratio. From the dose tank, the treated effluent is pressure-dosed into one of two subsurface drainfields (considered a single outfall, Outfall 001) that discharge on an alternating basis into Class III ground water.

A determination has been made by DEQ to reissue the Montana Ground Water Pollution Control System (MGWPCS) permit, MTX000205, to Coronado Resources USA, LLC., for the Madison Mine Project. This permitting action reauthorizes discharge of industrial wastewater to shallow ground water which underlies existing infiltration ponds (Outfall 001).

Outfall 001 is located in the West ½ of Section 01, Township 02 South, Range 06 West; or 45° 41' 34" North Latitude and -112° 17' 47" West Longitude.

PUBLIC COMMENT

During the public comment period provided by the notice, the Department will accept requests for a public hearing. A request for a public hearing must be in writing and must state the nature of the issue proposed to be raised in the hearing (ARM 17.30.1024).

The Department will respond to all substantive comments and issue a final decision within sixty days of this notice or as soon as possible thereafter. Additional information may be obtained upon request by calling (406) 444-3080 or by writing to the aforementioned address. The complete administrative record, including permit application and other pertinent information, is maintained at the Water Protection Bureau office in Helena and is available for review during business hours.
