NOTICE OF APPLICATIONS FOR OPERATING AUTHORITY

The following applicants have filed applications with the Montana Public Service Commission, under Title 69, Chapter 12, MCA, for a Certificate of Public Convenience and Necessity:

Motor carriers with proper standing may protest applications. Protests must be in writing and mailed to the following address: Montana Public Service Commission, Transportation Division, PO Box 202601, Helena, MT 59620-2601. Protests must be postmarked by **November 24, 2014**. **PLEASE NOTE:** It is the responsibility of the person submitting a protest to ensure the postmark date. The postmark date on the envelope will control, and late protests will not be accepted. If a person submitting a protest is unsure of the postmark date, he/she should check with the post office. Protests must include the proper fee, as required by ARM 38.3.402(c), and conform exactly to the requirements at ARM 38.3.405. These rules may be viewed and printed by following the link at the Commission's website <http://psc.mt.gov/transportation>, along with a protest form. Assistance in filing a protest may be obtained by calling the Commission at (406) 444-6199. ***A copy of the protest must be mailed to the designated representative of the applicant if shown. If no designated representative is indicated, a copy of the protest must be mailed to the applicant.***

If no written protests are received, postmarked by **November 24, 2014**, the Commission may issue a final order on the application without a public hearing, pursuant to Section 69-12-321, MCA. If a protest is received, a public hearing will be scheduled. Individual notice of the hearing will be given only to the protestants and the applicant.

Any interested person who does not want to formally participate in the matter as a protestant may submit written public comments to the Public Service Commission at the above address. Public comments may also be submitted to the Public Service Commission through the web-based comment form at <http://psc.mt.gov/Consumers/comments/>. Public comments, written or electronic, must be submitted no later than **November 24, 2014**. Please include the docket number of this matter in public comments.

In considering the application, the Commission may examine all matters pertinent to the applicant's operations, and will determine whether to grant, modify or deny the certificate application. The

Commission may issue the exercise only of the privilege sought and may attach to the exercise of the rights granted by the certificate such terms and conditions as in its judgment the public convenience and necessity may require. The Commission may also find that the applicant is entitled to receive a form of authority other than that applied for, however, the Commission will not grant a form of operating authority beyond the scope of authority for which the applicant originally applied.

Any interested party has the right to be represented by legal counsel at the hearing.

Randy Cowger dba Glacier Taxi, 271 3rd Ave EN, Columbia Falls, Montana 59912, has filed an application for a change of limitation on applicants current Montana Intrastate Certificate of Public Convenience and Necessity PSC 9015. The purpose of this application is to remove limitation 1) that *limits movements within the city limits of Kalispell, Montana*. Authority currently reads:

Class B - 1) Persons, baggage and express within Flathead County, Montana and 2) Persons and baggage between all points and places in Flathead County, Montana and the Veterans Hospital at Fort Harrison. Limitations: 1) Movements both originating and terminating within the city limits of Kalispell, Montana are prohibited. 2) Carrier is precluded from operating vehicles with a seating capacity above eight with the exception of the transportation of children and attendants originating or terminating in Columbia Falls and nine (9) miles to or from Big Mountain.

The new authority would read as follows:

Class B - 1) Persons, baggage and express within Flathead County, Montana and 2) Persons and baggage between all points and places in Flathead County, Montana and the Veterans Hospital at Fort Harrison. Limitations: 1) Carrier is precluded from operating vehicles with a seating capacity above eight with the exception of the transportation of children and attendants originating or terminating in Columbia Falls and nine (9) miles to or from Big Mountain.

Queen City Limousine Inc., 1025 Phoenix Ave, Helena, Montana 59601, has filed an application for transfer to Montana Intrastate Certificate of Public Convenience and Necessity, PSC No. 9020 to UG Inc dba Queen City Limousine, 1025 Phoenix Ave, Helena, Montana 59601.

Class B - Passengers by limousine between all points and places within a fifty (50) mile radius of Helena, Montana, and within all points and places in Jefferson County; also from all of the foregoing points to all points in Montana, and from all points in Montana to all of the foregoing points. Limitations: 1) Transportation is limited to nine (9) passengers and further limited to limousine transportation only. 2) Transportation as a jitney or taxi is prohibited. 3) Reservations for limousine service must be made at least eight (8) hours in advance. 4) Transportation which originates in Silver Bow, Deer Lodge, Granite, Powell, Beaverhead, Ravalli and Cascade Counties is prohibited; however, transportation which originates in Jefferson County or points within a fifty (50) mile radius of Helena and which is performed as a continuous round trip movement to points in Silver Bow, Deer Lodge, Granite, Powell, Beaverhead, Ravalli, and Cascade Counties and return may be performed
