Objective

To introduce and educate newly elected officials about NACo and the valuable resource NACo can be for them and their county.

- Each state association can nominate two newly elected officials to attend either the NACo Legislative or Annual Conference – with a *complimentary registration*. One newly elected *must* be from a non-member county if your state is not a 100 percent state.
