PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Department's intention to issue wastewater discharge permits to the facilities listed in this notice. These permits are issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); ARM 17.30.1001 *et seq.*, Montana Ground Water Pollution Control System (MGWPCS); and Sections 402 and 303 of the Federal Clean Water Act. The Water Protection Bureau has prepared draft permits for the facilities listed below. Copies of the draft permits, fact sheets, and environmental assessments are available upon request from the Water Protection Bureau or on the Department's website [www.deq.mt.gov](http://www.deq.mt.gov).

APPLICANT: Peak Health and Wellness Center LLC.

FACILITY LOCATION: The site is located south of the City of Missoula, on Highway 93.

A tentative determination has been made by DEQ to renew the Montana Ground Water Pollution Control System (MGWPCS) permit, MTX000213, to Peak Health and Wellness Center LLC for the Peak Health and Wellness Center facility. This permitting action reauthorizes discharge of treated domestic wastewater to ground water.

The proposed facility serves as a centralized collection, treatment and disposal system for businesses located at and near the Peak Health and Wellness Center.

The facility will treat domestic in nature wastewater utilizing a sequencing batch reactor treatment system discharging to a pressure dosed underground drainfield.

The proposed facility will use subsurface structures (Outfall 001) to discharge treated wastewater to underlying groundwater. The discharge structure's location is:

SW1/4, S2, T12N, R20W, (46 49'29.13"N, 114 4'41.21"W), Missoula County.

This permit is a reissuance of a Montana Pollutant Discharge Elimination System (MPDES) permit for discharge of treated wastewater from the Town of Philipsburg Wastewater Treatment Facility (WWTF) to Flint Creek. A fact sheet is available for review, and describes the rationale for the permit renewal. The applicant operates a two-cell facultative lagoon system incorporating primary separation followed by secondary treatment. The average facility design flow is 0.16 million gallons per day (mgd) and effluent is discharged from Outfall 001 to Flint Creek. The proposed permit will continue to apply limits for 5-day biochemical oxygen demand (BOD5), total suspended solids (TSS), Escherichia coli (E. coli) bacteria, and pH. Proposed changes from the previous permit include more stringent limits for nutrients. The proposed permit requires periodic self-monitoring of discharge quality and quantity, with monthly reporting of results. This permit and fact sheet will be submitted to the EPA for approval.

PUBLIC COMMENT

All comments received or postmarked PRIOR TO CLOSE OF BUSINESS August 19, 2015 will be considered in the formulation of final determinations to be imposed on the permits. During the public comment period provided by the notice, the Department will accept requests for a public hearing. A request for a public hearing must be in writing and must state the nature of the issue proposed to be raised in the hearing (ARM 17.30.1373 and 17.30.1024).
