Dear Commissioners,

The attached list of Ravalli County residents/Mill Creek Road residents/resident voters are hereby petitioning the county to have Mill Creek Road paved.

It is our understanding that our yearly, property tax billings do NOT reflect a credit for having an unpaved road on which we reside. Rather, we pay property taxes the same as other residents in the county which enjoy a paved surface on their roads.

Currently, Mill Creek is graded several times per year. Efforts on our behalf to have the road treated for dust abatement are futile given one or two such road gradings.

Besides the dust being unhealthful, it is a daily reminder to our wives who must clean the house frequently because of the dust accumulation.

In the past, we've complained individually, and that just doesn't seem to do any good. Hopefully, this list of unified, concerned residents will have the desired effect to finally have the road paved. While the county will still have to plow the road in the winter, it will cut down on the current, futile road gradings which only creates more dust.
