BUDGET AMENDMENT PROCLAMATION
HAMILTON SCHOOL DISTRICT
RAVALLI COUNTY**

At a regular meeting of the board of trustees of School District No. 3, Ravalli County, Montana, held **November 10, 2015**, at 6:30 p.m. in the Daly Den at Daly Elementary, the following resolution was introduced:

WHEREAS, the trustees of School District No. 3, Ravalli County, Montana, have made a determination that as a result of a Legislative Action on SB 213, the district's budget for the Building Reserve Fund does not provide sufficient financing to properly support and improve school safety for the entire current school year; and

WHEREAS, the trustees have determined that an amendment to the building reserve fund budget in the amount of **\$74,949.50** necessary under the provision of SB 348; and

WHEREAS, the anticipated source of financing the budget amendment expenditures shall be Bus Depreciation Fund Reserves;

THEREFORE BE IT RESOLVED that the Board of Trustees of School District No. 3, Ravalli County, Montana, proclaims the need for an amendment to the building reserve fund budget for fiscal year 2015-2016 in the amount of **\$74,949.50** according to SB 213, for the purpose identified above, and;

BE IT FURTHER RESOLVED that the Board of Trustees of School District No. 3, Ravalli County, Montana, will meet at 6:30 p.m. in the Daly Den at Daly Elementary School on **December 14, 2015**, for the purpose of considering and adopting the budget amendment.


