Re: Montana Public Records Act Request

Dear Glenda Wiles, Administrative Assistant:

Under the Montana Public Records Act § 2-6-101 et seq., I am requesting an opportunity to inspect or obtain copies of public records and documents that include emails, correspondence and minutes of meetings regarding the Ravalli County Airport Expansion project, that have not been previously provided to ICAARE.

The term "documents" includes letters, correspondence, memorandum, emails, text messages, data compilations, notes of meetings, notes of phone calls regarding the Ravalli County Airport Expansion project.

I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of the Ravalli County Airport Expansion project. Informing Citizens Against Airport Runway Expansion (ICAARE) is a non-profit corporation whose purpose is to inform citizens about issues related to the Ravalli County Airport and to advocate for a safe, reasonable design that protects homeowners and the environment. This information is not being sought for commercial purposes.

If access to the records I am requesting will take longer than a 'reasonable' amount of time, please contact me with information about when I might expect copies or the ability to inspect the requested records. If you intend to charge for this request, please inform me before incurring fees in excess of \$50.00.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law. Feel free to contact me for additional information or clarification regarding this request.


