PUBLIC NOTICE

Todd Townsend submitted an application for an Opencut Mining Permit to the Department of Environmental Quality (DEQ) which was deemed complete on October 10, 2017. Todd Townsend proposes to remove approximately 10,756 cubic yards of topsoil and overburden to be used for reclamation and 400,000 cubic yards of soil and aggregate material to be processed for various products for sale. Operations have been scheduled to begin approximately January 2018 and be completed by December 2032. The proposed plan would cover 10.1 acres. The site is located on private land in a portion of Township 8 North, Range 20 East, Section 18, in Ravalli County. The site is approximately two miles North of Victor located at the intersection of Meridian Road and Curlew Orchard Road. Access is off Rock Ranch Road.
