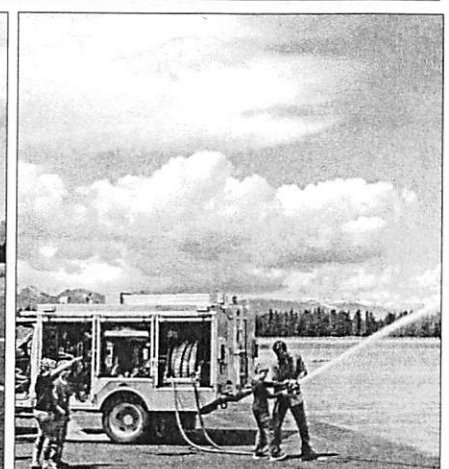
West Yellowstone Elementary School Students Visit Yellowstone Airport

Once again, Yellowstone Airport (WYS) hosted an annual field trip on May 29, 2018, for the first and fourth grade students of West Yellowstone School. The students spent half a day learning about activities involved in operating an airport.

To begin the field trip, the students received a tour of the SkyWest Airlines ticket counter where they learned about the check-in process. From there, they continued on to the Transportation Security Administration's (TSA) checkpoint and learned about TSA's purpose and function. They were also able to go through the walkthrough metal detector and see what a carry-on bag and its contents look like as it goes through the x-ray machine.

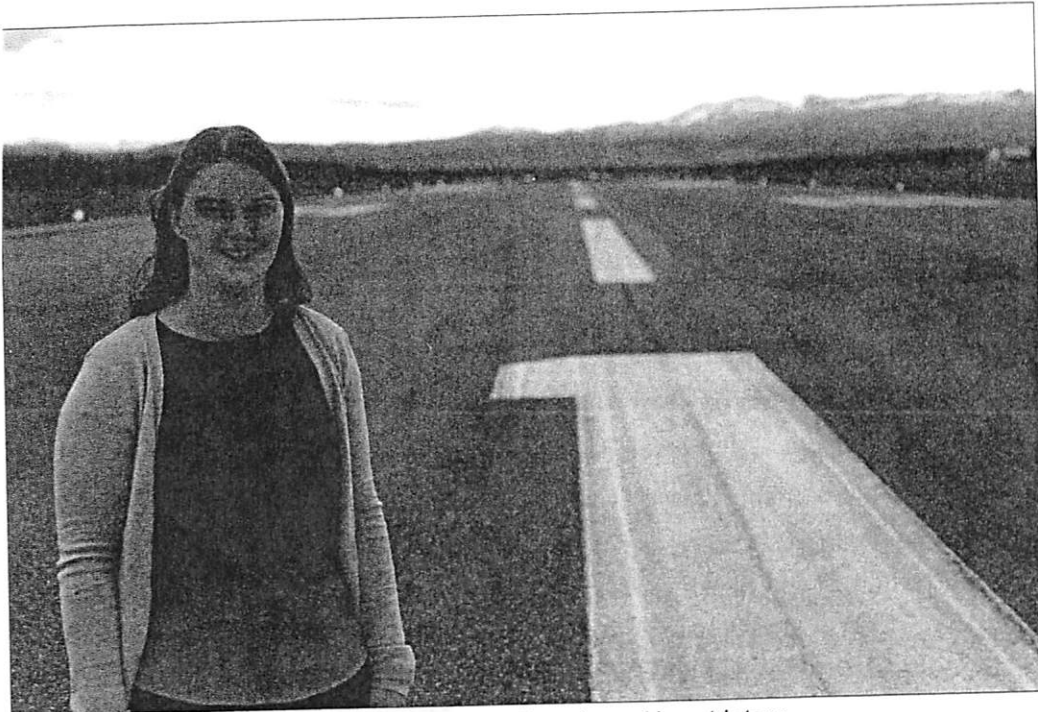
Next, the students headed out to the ramp where the SkyWest agent, Michael Castagnet, taught them how passengers and checked bags are loaded onto the airplane and how the planes are safely marshalled into and out of the ramp area. The kids had a blast pretending that the SkyWest agent was a plane and marshalling him in and out of the airline ramp area.

The field trip ended with the students rotating through a variety of activities. They had the opportunity to fly a Cessna 172 flight simulator, tour a Beechcraft Bonanza, climb through the airport's two firetrucks, build a balsa wood aircraft, and learn about Air Methods' medical transport helicopter and operations. The students had a great time at the airport, and many hope to make a career for themselves in the aviation industry in the future.

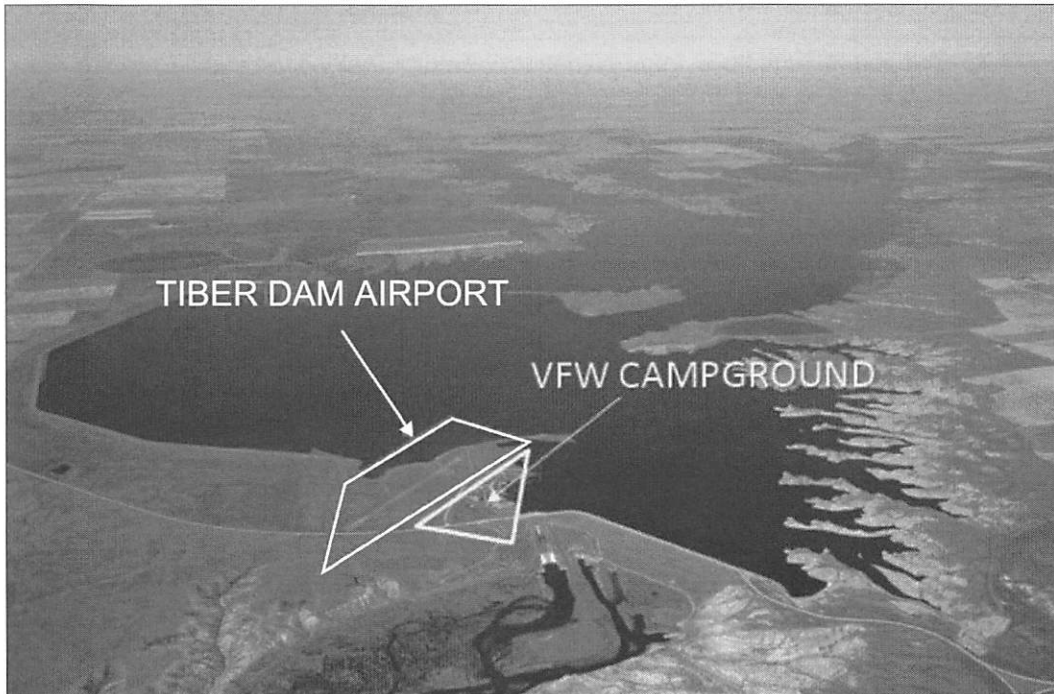

Tiber Dam Airport (B70)

Picturesque Stopover with Campground Next Door



The Tiber Dam Airport (B70) in north central Montana is one of 16 state-owned, public use airports maintained by the Montana Department of Transportation – Aeronautics Division. The turf runway 12/30 is 2,550' long and 90' wide at an elevation of 3,023' Mean Sea Level (MSL). Located 51 Nautical Miles (NM) north of Great Falls International Airport (KGTF), B70 opened in 1959 and lies along the southeast shore of Lake Elwell. Lake Elwell, also known as Tiber Reservoir, is a man-made reservoir created by the Tiber Dam (completed in 1956) on the Marias River with a surface area of 23 square miles. The area offers spectacular views, hiking, fishing,

and birdwatching. The Bureau of Reclamation operates a nice public use Veterans of Foreign Wars (VFW) campground and shelter next to the airport. More information about the campground can be found at: <https://www.visitmt.com/listings/general/recreation-area-campground/vfw-campground.html>.

Fly into Philipsburg Airport / Riddick Field to See the Many Improvements

If you haven't flown into Philipsburg / Riddick Field in the last 12 months you are in for a nice surprise. Interim manager of Riddick Field, Vince Reece, with the help of many, has made quite a few accomplishments.

The Airport Board and the Commissioners approved the purchase of a courtesy car for Riddick Field. Many pilots get a welcome surprise when they land and learn there is a courtesy car available. The response from pilots using the car to go into Philipsburg has been positive.

A clean and weekly serviced port-a-potty was deposited at Riddick Field to replace the dilapidated door-less shed that served as a toilet for pilots and their guests. This was a much-appreciated addition to the airport.

The County Commissioners approved an Airport Board-recommended resolution 2017-9. That resolution included several goals, one being to clean up the airport concerning non-aviation use. Several hangars had been used

for storage of personal items not leaving room for an airplane. Another goal of the resolution is to repair or remove hangars that cannot structurally house an aircraft. Two hangars have been demolished and removed. Building codes for new hangars will be addressed at the next board meeting. The resolution also brings forth new leases and liability insurance requirements.

The perimeter fence around the airport and entrance gate were in terrible shape. The gate has been replaced and the fence straightened and tightened after replacing missing wire and posts. The improved fence, although not the best, serves its purpose and the gate is working nicely.

There are a number of additional items on the list for future improvements; runway, taxiway, and ramp repair, to name a few. A survey and cost estimate have been completed and approved, and funding avenues are being explored.

Philipsburg and Drummond airports now have an Incident Operating Plan on file. With the help of the MDT Aeronautic Division, the County Attorney, and the Airport Board, a plan was written and approved by the Commissioners. The use of a safe airport is paramount for firefighting, and this plan gives the Air Operations team guidelines, safety procedures, and FAA Regulation concerning the airport. This Incident Operation Plan in no way interferes with the efficiency or effectiveness of the firefighters; it protects them and the airport, and they are very appreciative to have this in place.

Vince "believes that having an actual functioning airport will be a plus for the young men and women growing up in Granite County. There are so many good jobs available in Montana in the field of aviation. Things are moving ahead and stuff is getting done. My thanks again to all involved. I appreciate you all."

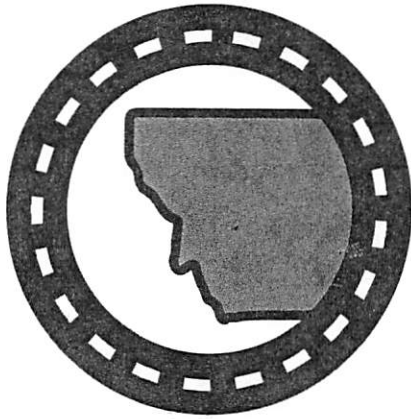

In 2017, there were 187 fatalities on Montana roads.

What does that mean? 187 parents, children, grandparents, friends, siblings, spouses, and other loved ones had lives that were cut short. It also means countless tears and shattered lives for those left with the aftermath of unsafe driving behaviors. Which loved one are you prepared to lose? If your answer is none, then Vision Zero is also YOUR goal.

It will take every one of us to work towards the day that Vision Zero is met, and the fatality total reads "ZERO." Two of the highest contributing factors to traffic fatalities in 2017 were alcohol and no seat belt.

These are behaviors that can be changed! Start by always wearing your seatbelt and planning for sober transportation. Remind your loved ones and those around you to do the same.
