

## Course Description

This course meets the requirements outlined in OSHA 29 CFR 1910.120 for 8 (eight) hours of annual refresher training for workers at hazardous waste sites. This course is designed for general site workers who remove hazardous waste or who are exposed or potentially exposed to hazardous substances or health hazards, such as those encountered at solid waste facilities.

The course is comprised of nine sections covering topics pertaining to workplace hazards associated with Hazardous Waste Operations and Emergency Response (HAZWOPER). Topics include HAZWOPER regulations, Site Characterization, Toxicology, Hazard Recognition, Personal Protective Equipment, Decontamination, Medical Surveillance, Confined Space Entry and Emergency Procedures.

Upon successful completion of the course you will receive a certificate of completion which is accepted by OSHA as documentation of training.
